VALENTINO C. PERDIDO, OIC-REGIONAL EXECUTIVE DIRECTOR AND BARANGAY HEALTH WORKERS ASSOCIATION OF DINGRAS (BHWAD) REPRESENTED BY MRS. MILDRED FERNANDO AND MUNICIPAL EMPLOYEES ASSOCIATION OF DINGRAS (MEAD) REPRESENTED BY MR. GEMINI GEORGE PASCUA REGARDING THE PROVISION OF 4 HEADS BREEDER DOE FOR BHWAD UNDER MULTIPLIER PRODUCTION FARM FOR GOAT (GOAT PRODUCTION PROJECT) AND 1 HEAD BREEDER BUCK FOR MEAD UNDER MALE BREEDER LOAN PROGRAM IN GOAT (BUCK LOAN FOR BREVITY) IN DINGRAS, ILOCOS NORTE.

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.






